On 21<sup>st</sup> June, 2024, Hon'ble Mr. Justice Sanjiv Khanna, Judge, Supreme Court of India & Executive Chairman, NALSA, chaired the Conference of DLSAs of Jammu & Kashmir and Ladakh at the State Judicial Academy, Srinagar. During the Conference, Justice Sanjiv Khanna interacted with the Ld. Chairpersons and Secretaries of DLSAs to understand the challenges faced by the Legal Services Institutions and the best practices being adopted to overcome these challenges. Justice Khanna also interacted with the PLVs and lauded them for the commendable work being done by them in the remote parts of the State despite the difficult terrain and extreme weather conditions. He harped on the need to strengthen the legal aid functionaries by organizing frequent training programmes for them and providing them necessary logistical support.

# UTRC FRAMEWORK AND SCHEDULE- 2024

On 08<sup>th</sup> April, 2024, Hon'ble Mr. Justice Sanjiv Khanna, Judge, Supreme Court of India and Executive Chairman, NALSA, formally released a "Framework and Schedule for Quarterly Meetings of Under Trial Review Committees" for the year 2024. The virtual launch was attended by the Hon'ble Executive Chairpersons and Ld. Member Secretaries of the various State Legal Services Authorities; Ld. Chairpersons and Secretaries of the DLSAs; and other members of the UTRCs. Hon'ble Mr. Justice Sanjiv Khanna, while highlighting the crucial mandate of UTRCs to prevent long periods of incarceration during pendency of trial, gave a rallying call for further streamlining, strengthening, and reinvigorating functioning of the UTRCs in every district across India.

Gupta, Judge, High Court of Allahabad & Executive Chairman, Uttar Pradesh State Legal Services Authority visited the Naini Jail, Prayagraj, Uttar Pradesh. He interacted with the prisoners and inspected the various prison facilities. He also inspected the Prison Legal Aid Clinic to monitor whether the guidelines issued by NALSA for the Prison Legal Aid Clinics were being followed in letter and spirit. Ld. Member Secretary, UPSLSA Ld. Principal District and Sessions Judge, Prayagraj, also accompanied the Hon'ble Executive Chairman, UPSLSA.

In our efforts to make societies more resilient to crime and to promote social cohesion, we must treat prisoners with respect, which is inherently due to them as human beings. In May, 2024, Delhi State Legal Services Authority started a project across all jails in Delhi to provide comprehensive rehabilitation and reintegration support to prisoners who had participated in skill development programs within the jails. A *Job Mela* was organized to facilitate their placements in the food and beverage industry.

## At Jails: Rekindling Hope behind Bars

Every individual deserves a second chance. However, in the confines of a jail, the prisoners often find themselves condemned to a life of doom and gloom. Very often they lose sight of the future. With a view to humanize the justice system and rekindle hopes in the hearts of the prisoners, DLSA, Srinagar in collaboration with the Jail Authorities at Central Jail, Srinagar has been coming up with different initiatives and programmes. By imparting one skill at a time through courses on calligraphy, painting, cooking, baking etc., these Authorities have been striving to unlock the potential of the prisoners, thereby transforming their lives.

## ***Success Story 1: Empowering Justice, Enriching Hapless Lives***

A disconsolate widow Smt. Bheemvarapu Manga approached DLSA Rajamahendravaram, Andhra Pradesh with a grievance that after the death of her husband, his employer i.e. Rajamahendravaram Municipal Corporation had not released his financial dues, leaving her and her children bereft of financial means. The Ld. Secretary, DLSA Rajamahendravaram promptly intervened in the matter and called for reports from Rajamahendravaram Municipal Corporation. Thus, nudged into action by the letter of the Ld. Secretary, DLSA, Rajamahendravaram Municipal Corporation released the dues to the widow, which were to the tune of Rs. 28,93,071.

## ***Success Story 2: Bringing joyous tears of reunion***

A child had accidentally wandered away from his home in Jamalpur District, Bangladesh and entered the border State of Assam in 2021, as the Covid pandemic wreaked havoc across the world. Found loitering, the child had been sent to a child-care institution in Boko, Kamrup, Assam. When his case was brought to the notice of Ld. Secretary, DLSA, South Salmara-Mankachar, Assam, he was provided legal assistance and steps for his repatriation to his homeland were initiated. After sustained efforts requiring coordination with multiple stakeholders, on 26th April, 2024, the child was handed over to the Border Guard Police of Bangladesh and successfully reunited with his family.

## ***Success Story 3: Empowering young girls by securing bodily autonomy***

While conducting a Legal Awareness and Outreach Programme, a PLV empanelled with DLSA Rajnandgaon, Chhattisgarh came across a 12 years old girl, who was a victim of sexual abuse. The girl was found to be pregnant. The PLV immediately reported the matter to the Ld. Secretary, DLSA, Rajnandgaon, who then interacted with the parents of the girl and informed them about the legal formalities before the pregnancy could be medically terminated. The girl was provided legal assistance to move application seeking permission to abort the foetus. The permission was subsequently granted by the Hon'ble High Court and soon thereafter, the pregnancy was terminated.

## ***Success Story 4: Empowering Lives: Timely Legal Aid Brings Hope***

On coming across a widow, who had two minor children to support and no financial means to do so, a PLV in Dhanbad, Jharkhand, immediately informed the widow about the Sponsorship Scheme for children and Widow Pension Scheme. He assisted the widow in getting necessary documents for applying for benefits under the Schemes. The PLV with support and guidance from the Ld. Secretary DLSA, assisted the widow in presenting her case before the Child Welfare Committee and the District Child Protection Officer in Dhanbad. Very soon, the widow and her children were given the sponsorship and pension amount, thereby enabling them to live a life with dignity.

Legal aid has a functional role in strengthening the justice system. It empowers individuals to participate and engage with the public institutions and become equal.

# IN THE PIPELINE



The National Legal Services Authority (NALSA) in consultation with the Mediation and Conciliation Project Committee, Supreme Court of India (MCPC) is in the process of developing a 40+ hours Online Mediation Training Module. This Training Module aims to promote and increase the use of mediation for resolution of disputes, commercial or otherwise, to further the objectives of the Mediation Act, 2023.

The Training Module is being designed through formal and informal consultations with subject experts. It shall comprise 30+ hours of pre-recorded Technical Sessions and 10+ hours of online interactive Practical Sessions. The 30+ hours of pre-recorded Technical Sessions shall cover key aspects of mediation. Participants will be required to view these pre-recorded sessions within a specified timeframe. The 10+ hours Practical Sessions will be conducted through role plays, simulation exercises, live problem-solving exercises, etc. These sessions will be conducted on fixed dates. The Online Training Web-Portal shall be launched in September 2024 and applications for the Training Programme shall then be invited from Judicial officers or lawyers, with at least 10 years of experience in their respective fields.
