

From the desk of the Hon'ble Executive Chairman......

It is my pleasure to present this newsletter of the State Legal Services Authority, West Bengal, after formally taking over charge as its Executive Chairman. The paramount function which I expect this Authority to perform is to effectively serve the impecunious and underprivileged section of the society and to reach out to the remotest and most inaccessible parts of the State in order to render access to justice at the citizen's doorstep.

Legal services authorities have traversed a long way since its inception with an ever increasing spectrum of services and a wide compass of modes and means to cater to those who need the services of this Authority in the form of legal aid. Its mission now is to cater to the needs of those members of our society who are less privileged ranging from labourers working in unorganized sectors to those who are mentally challenged and especially those who are marginalized and socially ostracized.

I am aware that no amount of compensation can erase the trauma inflicted upon the victims of acid attack and sexual abuse, but in spite of that, Legal Services Authority, West Bengal, has stretched out its arms to such victims and provided economic assistance to them to the tune of Rupees four crores in order to help them survive and thrive. This is the year which marks the beginning of conceptualizing the One Stop Support Centre of SLSA, WB, namely, "BHORSHA", to cater to the legal necessities, rehabilitation and most importantly psychological requirements of victims of crime.

All the officers and other members of the team of the State Legal Services Authority comprising of nineteen (19) Districts Legal Services Authorities, spread over whole of the State of West Bengal must keep in mind that the mission of this Authority is to provide a comprehensive support system to victims of crimes culminating to reaffirmation of their faith in the idea of justice and social security as enshrined in our Constitution.


CJ raps govt for delay in legal services appt

Kolkata: It's been nearly three months now, but the state is yet to issue a notification announcing the name of the executive chairman of the State Legal Services Authority (SLSA). West Bengal, Justice Debastsh Kar Gupta, chief justice of the Calcutta High Court said on Friday. He said this while addressing at the SLSA's annual commendation ceremony. The chief justice is also the patron-in chief of SLSA.

The name of Justice Biswanath Somadder was recommended on August 16. As per law, the name is to be finalized by the governor after consultations with the chief justice of the Calcutta High Court. This happe ned on August 16 and Justice Somadder's name was finalised, but no notification has been issued yet I hope and trust that the government will understand the importance of this post and issue the notification," Justice Kar Gupta said.

Highlighting the importance of the SLSA and district legal services associations, the chief justice said:

"All citizens of India are notequal, for several reasons. Article 39A was included in our Constitution for this reason and to provide justice to all, irrespective of the person's social or economic status."

Justice Somadder, who is now officiating as chairman of SLSA, West Bengal, insisted that justice must reach the poorest man in the remotest part of the state. "This is what I told SLSA, WB member secretary Durga Khaitan. Those not privileged enough have to be given the opportunity. Things should not only be symbolic and figurative like the number of Lok Ada-

lats held. It has to be ensured that people from the margina lized society get complete justice. This was the dream of the framers of our Constitution," he said.

In 2018-19 (till October) SLSA, WB, has awarded and disbursed compensation of Rs 2.46 crore to victims. Of this, Rs 1.08 crore was awarded and disbursed to acid attack victims and Rs 1.28 crore to minors under the Pocso Act, During the day, advocate Jayanta Narayan Chatterjee was felicitated as the best panel lawyer of SLSA, WB. Nirmalendu Juin of Burdwan was declared the best para-legal volunteer.





A case being C.Case no. 27/14 is a case u/s 138 N.I. Act was pending between Birbhum District Central Co-operative Bank Ltd. vs. Yudhupati Ghosh in the court of Ld. Judicial Magistrate, Dubrajpur. After prolonged discussion made between the parties it was settled that accused will pay Rs. 10,000/- as settled amount and complainant gave his consent to that effect and he agreed to issue no due certificate as and when he will get the settled amount.

On being asked both the complainant and the accused said that they are satisfied and happy as the case was pending since 2014 but did not arrive any settlement. Through mediation this long pending case has been settled and complainant has shown his willingness to withdraw the case on the very next date after getting payment of settled amount.

One Tele-film was casted on success story of Birbhum DLSA by Doordarshan Kendra, Kolkata as per direction of NALSA.



One day one lady namely Manoara Bibi of Nanoor, Birbhum with a baby on her lap was brought before DLSA, Birbhum by a social worker of that locality. She was crying a lot. It came to know from her that her husband was living with her at her father's house. One baby was born from their said wedlock.

Thereafter her husband started quarreling with her in each and every matter. One day her husband left the house. She became

helpless and rushed to her matrimonial home but got no shelter there. Thereafter she tried to commit suicide but ultimately rescued by that social worker who brought her before this authority. Getting the information DLSA, Birbhum, sent notice to her husband with the help of Police and ultimately her husband appeared before the ADR Centre. Secretary, DLSA, Birbhum made several counselling and at last Manoara's husband agreed to take her back and promised to live with her as husband and wife. Doordarshan Kendra, Kolkata contacted with DLSA, Birbhum and relying on this success story of Birhum DLSA, they made a beautiful film under the name of 'AKELE NAHI HAI AAP' as per direction of NALSA and the same was telecasted on DD National on 11th March 2018 at 8.00 p.m.

WESLEYAN MISSION ASHRAM a drive of DLSA, North 24 Parganas to rescue and rehabilitate our own children:

In the month of May,2018 a news came into headline that some teenage girls of "Wesleyan Mission Ashram" situated in this district were subjected to brutal sexual torture by its North Korean owner. Secretary, DLSA, North 24 Parganas rushed to the ashram as per direction of Hon'ble High Court, Calcutta and conducted a thorough enquiry over the issue. DLSA, North 24-Parganas depicted clear picture of such kinds of homes and brought it into limelight. DLSA, North 24 Parganas kept vigil on the legal proceedings in the matter and took active participation in the shifting of victims in association with District Administration. After shifting DLSA provided counselling to the victims at Sukanya Home and took active role in the process of handing over of those kids to their parents or near relatives. Subsequently this authority visited "Swadhar Grihas" along with members of Central Women Commission and came to know about vulnerable situation of widows in those homes. Accordingly DLSA, North 24 Parganas formed a team comprising of Panel Lawyer and PLVs and sent them to those homes. The widows living in vulnerable situationeed have been identified and the process of providing pin-pointed solution to them is going on.

GO GREEN- an attempt of DLSA, North 24 Parganas To make pollution free environment:

North 24 Parganas is the most populous district in West Bengal. The density of population in this district is also very high. One of the major issues in the industrial and urban belt of this district is pollution. On the eve of "WORLD ENVIRONMENT DAY" DLSA, North 24 Parganas brought its new theme "GO-GREEN". To give a pollution free life to citizens of this District, DLSA, North 24 Parganas in association with Barasat Municipality launched its "GO GREEN" project. In this process DLSA, North 24 Parganas prepared a documentary with unique short films and famous song of "BHUPEN HAJARIKA" "O GANGA BOICHHO KANO". It was first shown in a seminar organised by DLSA at municipality hall before stake holders. Thereafter several meetings took place for banning plastics at Barasat Municipal area. PURBA MEDINIPUR

Effort to rescue kidnapped child Jhumpa Roy (name changed) (Kolaghat PS Case No. 476/17, GR 2351/17).

Jhumpa Roy, a minor girl of 14 years was kidnapped. Her father lodged FIR before the Kolaghat Police Station (PS). The allegation of the father of the minor girl was that his minor daughter was kidnapped by the accused with the help of others and she was kept in a secret place under confinement, for evil purpose. The unfortunate father went to the PS on several occasions for relief but in vain. The complaint alleged that the accused, an influential person was evading arrest. Failing to get any remedy from the PS, the complainant approached 'child line', which is being handled by one of the PLVs of the DLSA, Purba Medinipur. Ld. Advocate Palash Pattanayak was engaged by the DLSA, Purba Medinipur in this matter. In the mean time the accused got bail. The ld. Advocate engaged by the DLSA, Purba Medinipur remained steadfast in his effort to bring the minor daughter into the lap of her father and on 24.07.2018, he filed a petition before the Ld. CJM, Purba Medinipur. Ultimately the minor victim girl was recovered from the Custody of the accused on a subsequent date. This achievement was a big success for the team DLSA, Purba Medinipur.

MURSHIDABAD

PREVENTION OF CHILD MARRIAGES

This District Legal Services Authority, Murshidabad has prevented 86 child marriages with the help of the legal aid clinics in schools and has also prevented about 38 child marriages with the help of information from the local people.

SPECIAL CARE OF THE SENIOR CITIZENS IN THE OLD AGE HOMES





One Stop Support Centre to facilitate access to justice in West Bengal

In furtherance of the commitment to promote **Alternative Dispute Resolution (ADR)** mechanism and improve access to justice in West Bengal, the West Bengal State Legal Services Authority (WBSLSA) aims to launch 'Bhorsha', which will be first of its kind one-stop support centre for providing free legal services, psychological counselling, rehabilitation related advice and to facilitate pre-litigation conciliation and mediation under one roof in West Bengal.

'Bhorsha', intends to cater to the victims of physical abuse, sexual abuse and domestic violence, at the earliest stage when they arrive at the law enforcement agencies like police station to report the crime and are at their most traumatized and vulnerable state of mind. At this stage they need support of trained psychologists, Panel Advocates and Para legal Volunteers to provide them psychological and legal support. Bhorsha aspires to provide support also to the senior citizens and other victims. Bhorsha empathetically stand by them holding their hands, providing legal, psychological and other support as they walk through this difficult road to recovery and justice.
